Career adjustment support

For dancers still covered by the PISA regulation (i.e. if you had less than five years until retirement age at the turn of 2014/2015).

If you are a dancer and are covered by the PISA regulation (i.e. if you had less than five years until retirement age at the turn of 2014/2015), you are not covered by the SOK agreement. However, you may apply for career adjustment support from SOKstiftelsen.

You may apply for career adjustment support when your employment has ended but before you turn 44 years of age. In the form below you must certify when your employment ends. If incorrect information is provided, you may be liable for repayment.

The payment is based on the career adjustment support allocation of 10 percent of monthly salary (13.14 percent including employer contributions) paid in to SOKstiftelsen by your employer from 1 January 2015.

Please indicate employer below, if you have had several employers since 2015 you should state all, provided that they are covered by the SOK-agreement.

The amount is paid out as a one-time payment and is taxed as salary. An administration fee of SEK 200 is deducted. If you have other income you should check that the total tax deduction is sufficient to avoid residual tax. You can request higher tax deduction, enter the percentage in the box below.

SOKstiftelsen is using Swedbank Lön and Utbetalningstjänst. By registering your account number to the Swedbank register you can recieve your payment from SOKstiftelsen directly in your bank account. Read more at www.swedbank.se/kontoregister. Note that you do not have to be a customer in Swedbank to register your account number. In connection with the payment you will receive a specification per email from SOKstiftelsen with details about your adjustment support.
